* E-mail dated 05.03.22 from retired *Capitán de Navio* (Ship-of-the-Line Captain) Carlos Daniel Vázquez, former Argentine 4 Platoon Commander, Nacar Company, 5th Marine Infantry Battalion in the 1982 Falklands-Malvinas War. His *ad hoc* composite platoon of thirty-six Marines and Army soldiers defended the west end of Tumbledown during the war's final night on 13/14 June. Vázquez's outstanding leadership (in addition to the Royal Artillery's handling of a 'rogue' 105mm Light Gun incident) caused a six-hour delay to the 2nd Battalion, Scots Guards advance eastwards along Tumbledown. The planned 1st/7th Gurkha Rifles night assaults on Tumbledown's north-east spur and Mount William consequently took place in full daylight. Following an intensive ten-minute artillery eighteen-gun Regimental Fire Mission on the first objective, both were then taken unopposed by the Gurkhas as the *de facto* ceasefire gradually took hold.

On 25 November 2015 following an official investigation to examine again 4 Platoon's exploits during that final night, Vázquez received an upgraded *'Al Heroico Valor en Combate'* decoration at the Argentine Navy HQ in Buenos Aires.
